# Capitalising experiences and tools for mass tourism management in Mediterranean heritage sites through open data

#### Introduction

The HERIT DATA project (Interreg MED) organises its **Final Conference on the 7<sup>th</sup> of April, 2022** (13h30-18h00 CET), in **Madrid**, Spain (hybrid mode).

During the meeting, the project partners will showcase the key results of the project such as the pilot site installation, data collection and use for policymaking, the mass tourism management model and the mainstreaming model. The aim of this showcasing activity is to encourage their transferability to other administrations, organisations and stakeholders working in sustainable tourism, and to influence and improve current policies and practices.

A Capacity Building session will be organized on the basis of HERIT DATA's outputs and building on two Manuals on <u>Training for the Integrated Territorial Development</u> and on <u>Social and Economic Regeneration in the Mediterranean after the crisis</u>. This session is organized in cooperation with the Union for the Mediterranean to put into perspective the transfer and capitalisation of results in territories beyond the project's main geographical area of reference (EU side of the Mediterranean).

Besides, this event is also an opportunity to discuss the key policy recommendations arising from the project that have been identified based on its final results. Key actors, such as the Regional authorities involved and other Mediterranean territories, the Interreg Euro Med Programme, key European institutions for the sector (EC DG GROW, EP, UNWTO, UfM etc.) will gather to debate on the implementation of these recommendations across Mediterranean heritage sites.

Destinations involved in the project and beyond will also be invited to sign a Memorandum of Understanding to commit to the implementation of a sustainable, smart and innovative tourism through the possible replication of the project tools/methodology and especially the cooperation between several key tourism actors.

Finally, the participants will discuss paths for the implementation of these commitments within the Interreg Med Sustainable Tourism Community and the next programming period, and notably through the Interreg Euro-Med Programme for the implementation of an innovative and resilient sustainable tourism in the Mediterranean.
